## **Contract Definitions**

**Type A (i.e, Lifecare Contracts)** - Comprehensive contract type that covers services and housing options without a substantial increase in monthly payments, less inflation and resident package selection. Typically Type A plans have high entrance and service fees.

**Type B (i.e, Modified Lifecare)** - Mixed contract type that typically covers a specified cost of care needed at a later time. Days beyond predetermined amounts will be billed at market rates. Type B plans usually have lower entrance and monthly fees.

**Type C (i.e, Fee-for-Service)** - Fee-based contract type covering a mix of services and housing options; however. this plan also features a higher monthly payment if the resident requires higher levels of care.
